Sub: Mandatory furnishing/updation of PAN, KYC Details and Nomination against your Holding of Physical Securities

The Securities and Exchange Board of India ('SEBI') vide its Circular No. SEBI/HO/MIRSD/MIRSD-PoD-1/P/CIR/2023/37 dated March 16, 2023 has made it mandatory for the shareholders holding securities in physical form to furnish PAN, KYC and Nomination details to the Registrar and Transfer Agent ('RTA') of the Company.

In view of the above, shareholders of the Company holding securities in physical form are requested to provide the following documents/details to RTA:

- Self-attested copy of PAN and Specimen Signature attested by your Banker
- Nomination in Form No.SH-13 or submission of declaration to 'Opt-out' in Form ISR-3
- Contact details including Postal address with PIN code, Mobile Number & E-mail address in Form ISR1;
- Bank Account details including Bank name and branch, Bank account number & IFS code;

Note: Any cancellation or change in nomination shall be provided in Form No.SH-14

All of above required documents/details shall be provided to Company's RTA at the address printed overleaf.
